Subject:- Discipline : DAD Establishment: Shri R.P. Srivastava, DEO 'A', A/c No 8328647.

Consequent upon conviction by the Special Judge (Ayodhya Prakaran) / Additional Sessions Judge, Lucknow, vide Judgment dated 15/05/2008 in Sessions Trial No 707/2002 on a criminal charge, under Section 302 & 498-A of the I.P.C. and Section 4 of the Dowry Prohibition Act, Shri R.P.Srivastava, DEO 'A', A/c No 8328647 was awarded the penalty of 'removal from service' with immediate effect by the Competent Disciplinary Authority. On compassionate considerations, it was further ordered to grant compassionate allowance equal to 50% of the amount admissible to Shri R.P.Srivastava, DEO 'A', A/c No 8328647 if he had retired on compensation pension. Aggrieved by this, Shri R.P.Srivastava, DEO 'A', A/c No 8328647 preferred an appeal dated 29/03/2011 to the Appellate Authority within the stipulated period of forty five days.

The Appellate Authority viz. CGDA, Delhi Cantt, after taking in to account all the facts, relevant to the case, found no merit in the appeal and has come to the conclusion that there are no justified grounds for interfering with the orders of the Disciplinary Authority viz. the Pr. CDA (CC) Lucknow and accordingly has rejected the appeal dated 29/03/2011, preferred by Shri R.P.Srivastava, DEO 'A', A/c No 8328647.
