Subject: - Promotion from the grade of Senior Accounts Officer (Group 'B') to the Junior Time Scale (Group 'A') of Indian Defence Accounts Service (pay scale of Rs.15600 – 39100 plus 5400 (Grade Pay).

Consequent upon selection for promotion to the Junior Time Scale Rs. 15600 – 39100 plus 5400 (Grade pay) of the Indian Defence Accounts Service on adhoc basis with effect from 27-09-2011 or from the date of assumption of charge whichever is later and having been decided to post the officer from the O/o the LAO (Army) Jabalpur to the O/o the AAO (CC) Kanpur under the organization of the PCDA(CC) Lucknow by the CGDA Delhi Cantt. vide letter No AN-I/1424/1/XXXIII dated 27-09-2011, Sh. Menon, SAO / 8317073 has been relieved from the O/o the LAO (Army) Jabalpur on 18-10-2011(AN) and he has assumed his duties in the O/o the AAO (CC) Kanpur on 31-10-2011(FN) in the Junior Time Scale of IDAS on adhoc basis.

2. Accordingly, Sh. M. Menon, SAO / 8317073 has been promoted to the grade of Junior Time Scale of Indian Defence Accounts Services on an adhoc basis in the revised pay scale of Rs.15600 – 39100 plus 5400 (Grade Pay) and designated as Assistant Controller of Defence Accounts w.e.f. the same date.

3. The promotion of the officers is purely on an adhoc and temporary basis. It neither bestows any claim on the officers for regular promotion to the post nor service rendered in the grade will count for the purpose of seniority in that grade or for promotion to the next higher grade. The pay of the officer granted ad hoc promotion will be regulated in terms of FR – 22(I)(a)(1) read with FR -35.
